

Prize Draw Terms and Conditions

UK

- The promoter of this prize draw is Wonde Limited, ("Wonde", "we" or "us").

- 2. The prize draw is open to all UK schools, and applicants authorised to enter into the prize draw on behalf of a school must be aged 18 years or over. Employees of Wonde, their families, agents or any third party directly associated with administration of the prize draw are not permitted to enter the prize draw.
- 3. Applicants that submit an entry by 17:00 (GMT) on 23rd January 2025 will be entered into the prize draw. Only one entry per School is permitted. There is no additional cost to enter the prize draw.
